Institutional affiliation, city, country and email address.

Abstract

The abstract must clearly articulate the relationship to the sub-theme/s chosen and make a significant contribution to social work and social development education, research, policy and/or practice, that impact individuals, families, groups, organizations and/or societies at large. The abstract must be logically written, and it must include the central ideas of the presentation. The presentation can consist of research based findings or theoretical and practice reflections. The abstract does not contain tables, figures or references.

Modalities of presentation

There are opportunities for multiple modalities of presentations as described below.

Parallel paper presentations

Individual or joint presentations that clearly articulate the sub-themes chosen. Abstract submission of no more than 300 words. Duration: 15 minutes.

Symposium

The symposium consists of three to four papers on a common topic presented in the same session. It is organised by the symposium presenters. It is aligned with the central theme of the conference and linked to one or more of the sub-themes. The symposium duration is 1.5 hours.

When choosing a symposium, one person is responsible for submitting:

- a general abstract of no more than 300 words describing the overall aim, objectives and outcomes of the symposium within the central theme of the conference and the subtheme/s chosen by the participants.
- an abstract of no more than 300 words for each of the papers included in the symposium.

Indicate which person is the symposium convener who will be the correspondence person. Preference will be given to symposia that are well motivated and those that reflect strong synergies across each of the presentations. Symposia spaces in the conference programme are limited.

Workshop

A workshop may be conducted by one or more persons. An abstract of up to 300 words must be submitted that reflects the key contents and design of the workshop, and how the workshop relates to the chosen sub-theme/s. Duration: 30 minutes.

Poster presentation

Posters may be created by an individual or group. The posters will be displayed in designated areas during the conference. The author/s of the posters will be available at particular times to speak to their posters and to address questions that delegates might have. An abstract of no more than 300 words must be submitted.

Creative performing arts contribution

These may be in the form of poetry, music, painting, brief videos/documentaries. An abstract of a maximum of 300 words, reflecting a clear articulation with the chosen sub-theme/s, must be submitted. Duration: 10 minutes
